### Lee Savarrio - Chief of Dentistry Update (28-4-2020)

#### GDS Referrals

Thank you to everyone who has started to use the new GDS Triage Form. Of the 97 referrals received at the PDS Special Care Hub on Monday 27-4-2020, 87 of these were forms emailed in and only 10 were telephone calls. This has really expedited the transfer of information and therefore the patient journey.

To allow us to track this patient journey from receipt of referral to completion of treatment, we have made some minor changes to the referral form (attached) to include both the date and time the GDP triages the patient and then when the referral is received and seen.ave also included a question about the patient's weight, so that we can ensure that if treatment is required, the patient can be seen at the most suitable site.

It is regrettable that we are making changes to the form quite so soon, however I am sure you may appreciate as we start to use the new triage form we become aware of feedback which helps us to refine the process and make the patient journey better.

It would also be helpful when emailing the referral form either to the PDS Special Care Hub or direct to GDH for urgent care that you include a patient identifier within the subject of the email (either CHI number or patient name and date of birth) to enable easy collation of information.

We have seen a large proportion of referrals coming into the PDS Special Care Hub very late in the day. If you think your patients needs seen that day, wherever possible, the referral needs to be with the Hub as early in the day as possible.

- You may recall in one of my updates last week we highlighted the fantastic work being done by the labs at GDH to manufacture visors. We have now received confirmation that the quality of the face shields designed for use by dental teams has passed the medical devices testing. The face shields passed this technical evaluation and are currently being assembled by the dental laboratory teams at GDH. Congratulations to all those involved.
- We continue to look for PPE, in particular Type IIR masks and implant PPE kits including surgical gowns. We are hoping to try and distribute these throughout the wider NHS family, including acute sites and Care Homes. Once again my thanks for your help and support.
